

Guidelines and Eligibility for ICGC Graduate Fellowship Competition

Deadline: 4:00pm, Friday, February 7, 2020

- ▶ Each DGS may nominate up to six candidates for ICGC Scholar Fellowships of which up to 3 may include ICGC Mellon Scholar Fellowships.
- ▶ ICGC encourages departments to nominate a diverse range of students including students from the global south and groups underrepresented in graduate education.
- ▶ ICGC accepts fellowship nominations for admitted students entering doctoral programs in the Colleges of Biological Sciences; Education and Human Development; Food, Agriculture, and Natural Resource Sciences; Liberal Arts; the School of Public Health or the Humphrey School of Public Affairs.
- ▶ ICGC also accepts fellowship nominations for admitted students entering master's programs in the School of Public Health as well as from the intercollegiate Master of Development Practice and Master of Human Rights programs. The majority of funding supports doctoral students. Because we offer a small number of fellowships for master's students, we limit the total number of nominations for master's students to six per college with no more than four from a single degree program.
- ▶ ICGC will again offers two fellowship tracks. The first track offers a standard ICGC Fellowship package similar to previous years' awards. The second track offers a fellowship package with a reduced financial commitment. Details on fellowship terms are included within this DGS Information Packet.

Submission Process

Programs must submit nominations through the [Graduate School's online application system](#) no later than 4:00pm on Friday, February 7, 2020. Instructions to nominate follow below.

- D** Indicate whether the student is being nominated for or received an offer for a CLA-GF, Dove or other Graduate Fellowship Award.

NOTIFICATION PROCESS

ICGC will begin to notify departments of awards in early March. Please be aware that our fellowship awards process continues on a rolling basis if fellowships are declined in the initial round. We provide intellectual and financial support to graduate students through the following fellowship programs.

ICGC Fellowships

Our core fellowship program has supported annual cohorts of graduate students since 1989

Eligibility:

To be considered for an ICGC Scholar/ICGC Mellon Scholar Fellowship, applicants must:

- ▶ Hold at least a Bachelor's degree
- ▶ Have applied and been admitted to a graduate or professional degree program at the Twin Cities campus of the University of Minnesota in the following categories:
 - Doctoral programs in the Colleges of Biological Sciences; Education and Human Development; Food, Agriculture, and Natural Resource Sciences; Liberal Arts; the School of Public Health or the Humphrey School of Public Affairs.
 - Master's programs in the School of Public Health as well as from the intercollegiate Master of Development Practice and Master of Human Rights programs.
- ▶ Receive a nomination for these fellowships by the program, department or college in which they will be enrolled

In reviewing nominees ICGC gives priority to students with academic interests related to global change, with a focus on the global south; potential for scholarly excellence; and a commitment to interdisciplinary work.

ICGC Graduate Fellowship Competition Funding Packages

- ▶ ICGC Fellowships are supported jointly by ICGC and the student's home department. Fellowship award terms vary depending upon the program/department, category of fellowship and whether students have other funding. ICGC's support is in the form of fellowship stipends with an expectation that the student's home department provides support in the form of tuition and health insurance during fellowship years and graduate assistantships or other forms of support during subsequent years.
- ▶ We are pleased to note that the Provost has again provided support to partially offset departmental costs (tuition, health insurance) of supporting ICGC Scholar awards for doctoral students. Depending upon the terms for the individual student, ICGC will use this funding to provide partial matching support to the home department of students receiving and accepting ICGC fellowships. Please consult with ICGC Director if you have questions concerning funding package details or how an ICGC award might be coordinated with other sources of funding for students.

A standard ICGC Scholar doctoral funding package follows:

For students enrolling in doctoral programs, the academic department of the award winner is expected to guarantee support in the form of 50% teaching or research assistantships in the second and third year of study, and tuition and health insurance benefits for four years. If your unit is unable to commit this level of student support, see ICGC Scholar Alternative Track.

For fellowship nominees who receive an alternate graduate fellowship in their first academic year, the alternate fellowship will replace the ICGC stipend for that year.

First Academic Year

ICGC provides a \$24,000 academic-year fellowship, **OR** Alternate Fellowship Terms apply (e.g. DOVE, CLA-GF or other graduate fellowship).

Summer

ICGC provides a \$4,000 pre-dissertation grant for exploratory fieldwork on student's dissertation project that will be granted upon approval of the student's advisor and receipt of a proposal acceptable to the ICGC faculty committee.

Research Year

ICGC provides dissertation research funding for a single semester (\$12,000) matched by a second semester of support from the student's home department.

A standard ICGC Mellon Scholar doctoral funding package follows:

For students enrolling in doctoral programs, the academic department of the award winner is expected to guarantee support in the form of 50% teaching or research assistantships in the second and third year of study, and tuition and health insurance benefits for four years.

First Academic Year

ICGC provides a \$24,000 academic-year fellowship.

Summer

ICGC provides a \$4,000 pre-dissertation grant for exploratory fieldwork on student's dissertation project that will be granted upon approval of the student's advisor and receipt of a proposal acceptable to the ICGC faculty committee.

Research Year

ICGC provides dissertation research funding for a single semester (\$12,000) matched by a second semester of support from the student's home department*.

**ICGC Mellon Scholars are required to spend approximately two months at the University of the Western Cape participating in the intellectual community and our partnership activities.*

ICGC Scholar Alternative Funding Track for doctoral students (reduced departmental financial commitment) funding package follows:

This alternative fellowship track reduces the departmental financial commitment while enabling recipients to participate fully as ICGC Scholars. The terms below outline alternative track minimum funding requirements. While this track does not require departments to provide support in years 2 and 3, we strongly recommend it.

First Academic Year

ICGC provides a single semester fellowship of \$12,000 for fall, department provides tuition and health insurance.

Department provides 50% Assistantship (RA or TA) for spring semester including tuition coverage up to 14 credits and health insurance benefits.

Summer

ICGC provides a \$4,000 pre-dissertation grant for exploratory fieldwork on student's dissertation project that will be granted upon approval of the student's advisor and receipt of a proposal acceptable to the ICGC faculty committee.

Research Year

ICGC provides dissertation research funding for a single semester (\$12,000) matched by a second semester of support from the student's home department. If possible, the department will provide tuition coverage up to the required 1 credit FTE registration each semester of the research year and subsidized health insurance for the academic year.

A standard master's funding package follows:

For students enrolling in eligible master's programs, the academic department or program of the award winner is expected to guarantee support in the form of a minimum 25% teaching or research assistantship in the second year of study and tuition and health insurance benefits for two years.

Academic Year One

ICGC provides a \$16,000 academic-year fellowship.

The department provides tuition coverage up to 16 credits each semester.

Summer

ICGC provides a \$4,000 ICGC grant to support the costs of the required field experience, to be granted upon approval of the advisor and receipt of a proposal acceptable to the ICGC faculty committee.

Academic Year Two

The department will provide a 25% time assistantship along with tuition coverage up to 16 credits each semester, and 95% of health insurance coverage for the academic year.

Note on other ICGC Fellowship programs:

The Joseph E. Schwartzberg Workable World Trust Fellowships support CLA admitted doctoral students conducting research related to global governance. As CLA departments nominate incoming students for ICGC Scholar fellowships, please note that we may offer students the Schwartzberg summer fellowship as part of their ICGC Scholar award package if their research interests relate to global governance. **DGS' do not need to nominate incoming students separately for these awards.**

ICGC periodically invites applications for the DSSC Minor program from students who are not ICGC Scholars. If our program size allows for additional minor program students in the coming year, we will contact Directors of Graduate Studies about this possibility.
